SL No.	The school is directed to ensure that :	
1	The total number of sections of the school shall be restricted to 16, of which not more than 1/3rd sections may be used for senior secondary classes. Any further increase of section shall require prior approval of the Board, subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.	
2	The ramp shown in the video is too steep, hence considered to be dangerous from the safety point of view of the CWSN students. The school is required to make provision with proper possible infrastructural facilities for CWSN students to access upper floors by a ramp or lift as prescribed by the RPwD Act 2016 and circular no. 5 dt. 6.3.2023 issued by the Board and submit the compliance through videography within 3 months on the SARAS portal	
3	Drains made for water drainage were found open at some places in the playground, which is not good from the safety point of view of the children, so school is advised to make all necessary arrangements to cover them and submit videographic proof within 3 months on the SARAS portal.	
4	There is no scating arrangement in the sports room, thus the school is required to make arrangement for seating and submit videographic proof within 3 months on the SARAS

5	The school shall ensure the training of its teachers with CoE Bhubaneswar within 3
	months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be
